#### **NOTICE TO BE GIVEN TO DEFENDANT BEING REFERRED TO LIBERTY COUNTY DUI COURT PROGRAM:**

The Liberty County DUI Court is an 18 month minimum, judicially supervised, drug treatment program, offered by Liberty County State Court. The program serves non-violent, misdemeanor-level offenders, whose criminal behavior is driven by alcohol addiction. You will be required to adhere to a daily curfew, maintain gainful employment, and attend bi-weekly court sessions. Participants are expected to attend treatment group sessions weekly. Each participant will attend individual treatment sessions with a Primary Counselor. Participants will meet with a Case Manager for assistance with job searches, employment requirements, housing, education, scheduling and financial budgeting. Participants are subject to drug screens up to 6-7 days per week, and are therefore charged \$45.00 for confirmations (contested test results only) throughout treatment for alcohol/drug screen costs. There are treatment cost related to DUI court required to be paid by participant as well (\$45 weekly for treatment cost) [\*total treatment fees \$3,510.00+/-] \*Based on grant awarded yearly.

**Prior to being considered for the program:** The Defendant's criminal background will be checked as the first part of the eligibility process, and if found to be eligible, the Defendant will then obtain an alcohol & drug assessment and clinical evaluation as the second part of the eligibility process, (**at a charge of \$110.00 (or greater) to them-that must be paid at the time of assessment**), whether they are incarcerated or in the community. Court Administrator will contact Defendant with Recovery Place contact information for them to schedule an assessment. If the Defendant is found **not to be eligible** for the program through either the criminal background check or the assessment/evaluation process, the Defendant's attorney will be notified that the referred Defendant was not accepted into the DUI Court Program. If the Defendant meets all the eligibility requirements above mentioned, the Defendant and attorney will go over the requirements of the Liberty DUI Court Program as well as the DUI Court Contract, prior to them being accepted into the program.
