

In order to obtain a permit for construction of a modular home you must have the following:

- 1. Zoning Approval from the Liberty Consolidated Planning Commission.**
- 2. Copy of your septic permit or city sewer tap in receipt.**
- 3. Copy of your well permit or city water tap in receipt.**
- 4. Approval from Road Dept. on your new or existing driveway.**
- 5. A copy of your approved plat.**
- 6. A plot plan with measurements from property lines.**
- 7. Two(2) complete sets of plans, including a footing and wall detail stamped by a Georgia State authorized third party inspection agency. Plans must contain a design criteria block stating wind zone, exposure category, and seismic zone. If there are special conditions such as the home being placed in a coastal or hurricane prone area, the plans must be stamped by a Georgia licensed engineer.**
- 8. Copy of the DCA Data Plate/Sticker stating the wind zone, exposure zone, and seismic zone. The insignia on the actual unit when delivered must match all criteria on the plans and must also be stamped by the third party inspection agency.**
- 9. A copy of the business license & state license for your general contractor, electrician, plumber, & HVAC contractors.**
- 10. A copy of the general contractor and concrete contractors business license.**
- 11. Building application page, contractors page, and affidavit sheet filled out.**

You are responsible for approvals from any subdivision Property Owner's Association for covenant requirements prior to actual construction. _____ Initial

I have been explained and understand the regulations pursuant to the State of Georgia Water Quality Control Act, Title 12 Chapter 5- that **NO CONSTRUCTION** may occur within 25 feet of the marsh, 50 feet on waters designated as "trout streams", as delineated by the Georgia Department of Natural Resources. **These setbacks are considered permanent buffers** and shall remain in its natural and undisturbed state. _____ Initial

I am aware that this project may be in violation of Federal Wetland Regulations and that I am responsible for contacting the Savannah District Office of the U.S. Army Corp of Engineers (USACE) at 912-652-5279 for a delineation of wetlands on my property before beginning this project. _____ Initial

For Houses Being Built In Flood Zone Areas

The regulation to build at or above the required flood elevation has been explained to me. I understand that areas below the required elevation may only be used for the parking of vehicles, building access (staircase or floodproofed elevators) and limited storage for equipment necessary for lawn or building maintenance. I understand that to enclose beneath the required elevation, there are strict requirements pertaining to hydrostatic vents or breakaway walls depending on the flood zone in which the building is located and that there can be no partitioning of rooms. I further understand that should I violate any of these regulations I may be required to remove the enclosure, that my insurance carrier may be notified and that further remedy may be sought through the courts. _____ Initial

An elevation certificate is required upon completion of the slab/floor before continuing up with the walls. _____ Initial

I hereby certify that I have read and examined this permit application and know the same to be true and correct. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. The granting of this permit does not presume to give authority to violate or cancel the provisions of any other state or local law regulating construction or the performance of construction. This permit becomes null and void if work or construction authorized is not commenced within (6) six months or if construction is suspended or abandoned for a period of (1) one year at anytime after work is commenced.
